FREQUENTLY ASKED QUESTIONS



What does United Way of Calgary and Area do?

United Way of Calgary and Area improves lives locally. We are a social impact organization that brings together agencies, donors, corporations, volunteers, and government to create lasting social change in the communities we serve. We lead key initiatives, build collaborations, convene on local issues, support and invest in the social services sector, and advocate for policies and system level change. With the caring support of thousands of donors, we connect a vast system of supports and services with the common goal of helping people overcome poverty, setting kids up for success, and building strong communities.

Why should I invest with United Way of Calgary and Area?

Your social investment with United Way stays local and is strategically invested right where you live, work, and raise your family. Your gift improves lives: it ensures people in our community have access to the supports they need the most, when and where they need them. Your social investment helps people overcome poverty, helps kids succeed, and strengthens neighbourhoods. We believe that these are critical components to realizing our vision of a resilient and caring community where everyone thrives. United Way is committed to a rigorous measurement process with annual reporting, and we generate high return on community investment.

Is United Way involved in policy and advocacy work?

Yes. The majority of United Way's work centers on partnering with many organizations in order to address immediate needs, and underlying causes of social issues. While the ultimate goal is to prevent these issues from happening in the first place, United Way recognizes that policy barriers exist at municipal, provincial, and federal levels. By advocating for change around these social policies, United Way can have a more significant impact in our community.

What is United Way of Calgary and Area's geographic scope?

All donations to United Way stay local, where they are invested in agencies, initiatives, and programs in the Calgary area – including Airdrie, Chestermere, Cochrane, High River, Okotoks, and Strathmore.

Are United Ways across Canada one big organization?

Canada has over 90 United Ways that are autonomous and operated by a voluntary Board of Directors within the communities they serve. Each United Way works locally to raise funds and invest in improving lives in its community.

How much of my investment does United Way of Calgary and Area use for fundraising and related operating costs?

United Way of Calgary and Area has one of the lowest fundraising cost ratios in Canada. Fundraising and related operating costs have been between 10% - 14% of total revenue for the last 10 years. The Canada Revenue Agency (CRA) considers 35% to be an acceptable standard. As a registered Canadian charity, United Way files a T3010 report with CRA annually, detailing all of its fundraising, related operating costs, executive compensation, and other costs. How are investment decisions made?

As part of United Way's stewardship of donor dollars, there is a rigorous process in place to ensure the best investment of resources. Experienced staff and volunteers make investment decisions based on community needs, research, and funding criteria. United Way invests to minimize duplication among programs and looks for measurable results, quality performance, and innovative approaches to solving social issues.

Does United Way ever discontinue funding to an agency or program?

Yes. Some programs are designed as "pilots" – specifically funded and planned for a pre-determined duration. There are also agencies where United Way reduces or discontinues funding for other reasons. An agency may have governance issues, outcome measurement shortfall, or simply no longer require United Way funding due to other funding sources, such as government grants. Before halting funding to an agency, United Way engages in discussion with the impacted agency to explore options that may help remedy performance or accountability issues, implement efficiency building strategies or engage United Way volunteers to assist with governance, financial management, or program delivery.

How much are United Way's senior executives paid?

All salaries at United Way, including senior management, are benchmarked against other Canadian non-profit organizations of similar size and scope. United Way of Calgary and Area is in compliance with the required T3010 regulatory reporting to CRA for its executive compensation, which can be viewed at www.cra-arc.gc.ca.

How does United Way protect donors' privacy?

United Way of Calgary and Area complies with the Association of Fundraising Professional's Donor Bill of Rights and is committed to protecting the privacy of your personal information. The information you provide is used to assist in the administration and acknowledgement of your gift, to issue tax receipts, and to fulfill your information questions. Why does United Way charge a \$12 processing fee for each donor choice designated gift?

Donor choice or "Donor Designation" is an added service United Way offers to its donors that allows them to direct their gift to any registered charity in Canada. United Way's core business is about making a measurable difference by focusing on our community priorities. The time and resources devoted to processing donor choice designations are costly and take us away from dedicating time to support our core business. The \$12 processing fee offsets the administration cost and ensures United Way can continue to meet the needs in our community.

I feel pressured to give, does United Way encourage this?

No. No one should feel pressured to give, and everyone should be given the opportunity to make an informed choice.
